**SUBJECT: MINUTES OF FINANCIAL BID OPENING MEETING**

The meeting was started with the recitation of Holly Quran. Afterwards, the Chairman Procurement Committee welcomed the members, and representatives of qualified firms. The Central Purchase Committee opened financial bids on **May 28<sup>th</sup> 2018 at 11:30am**, in the committee room of Vice Chancellor's Secretariat.

As per agenda, the financial bids of technically qualified offers were taken into consideration by the committee exclusively. The vendor's quoted rates were read aloud along with amount of attached bid security. The committee examined the bid as per qualification and eligibility; the committee checked arithmetical calculations and amount of bid security submitted with the bid.

After due deliberation and scrutiny of each bid document by the committee, it was unanimously decided that bids may be accepted on lowest item rate basis. Moreover, the committee apprised to the bidders that the rates quoted in CFR / C&F Basis will be converted in PKR for comparison, the currency exchange rate will be applicable as issued by State Bank of Pakistan for foreign exchange. Accordingly, it was also decided by the committee that the items may be procured with the consent of end user.

The committee informed all the bidders that Procurement Department has received few other demands of similar nature of equipment from few other departments of the University due to unavailability of such items. Hence, as per ITB clause 32.1 & para mentioned in bid data sheet, every bidder shall be bound to provide additional items on same rate & cost. The committee also informed them that in event the procuring agency realized that the cost of any item is on higher side, the committee shall drop it/those. In this regard, all the vendors confirmed the version of the committee and stated that all these matters/conditions are properly mentioned in the bidding document and they have no objection for addition / deletion of any item.

The meeting ended with the vote of thanks to all members.
