PUMHSW have an accessible faculty dedicated to teaching, and an educational model that encourages real world experiences. They are proud of our students and their deep commitment to completing their undergraduate education and improving the world in which we live. PUMHSW has a strong commitment to the improvement of the quality of education in Nawabshah, which is realized through the collaboration with other institutions.

 WHEREAS, both the parties are agreed to cooperate based on mutual trust and benefit for purpose of developing two universities and promoting international exchange and cooperation.

BOTH THE PARTIES ARE AGREED UPON THE FOLLOWING TERMS AND CONDITIONS

- 1. The objective of this MoU is to develop and promote ties between both universities and to promote academic exchange between the two countries.
- Both Government College University Faisalabad and Peoples University of Medical & Health Sciences for Women (PUMHSW), Nawabshah:
 - Human resources development;
 - Exchanges of faculty and administrative staff;
 - Exchanges of students;
 - Exchanges of research materials, publications, reports, and other academic information;

- Collaboration and research projects;
- Joint publications;
- Any other academic activities beneficial for both universities.
- A detailed description of every cooperation will be defined in separate documents, which shall be drawn up and agreed upon by Government College University Faisalabad and Peoples University of Medical & Health Sciences for Women (PUMHSW), Nawabshah.
- The two institutions understand that all financial arrangements will have to be negotiated and will depend on the availability of funds.
- 5. This agreement will come into effect when signed by the representatives of both institutions and will have duration of five (5) years. Extensions and/or modifications may be made as agreed in writing by both parties. Each party may cancel this agreement by providing the other with a written notice six (6) months prior to the date of cancelation.
- 6. Every notice, request or any other communication required or permitted to be given pursuant to this MoU shall be in writing and delivered to the Parties at their addresses. Authorized representative of Government College University Faisalabad and Peoples University of Medical & Health Sciences for Women (PUMHSW), Nawabshah shall sign two original MOU documents, both documents being equally authentic.

MEMORANDUM OF AGREEMENT (MOA) BETWEEN



GOVERNMENT COLLEGE UNIVERSITY, FAISALABAD (GCUF) AND

OF HUMAN RESOURCE AND RESEARCH DEVELOPMENT

This Memorandum of Agreement (MoA) is made and executed as addendum of Memorandum of Understanding (MoU) at Faisalabad, between The Government College University, Faisalabad, Pakistan through its Vice Chancellor/nominee (herein after called 1st Party) and Peoples University of Medical & Health Sciences for women, Nawabshah Through its Vice-Chancellor/nominee (herein after called 2nd Party).

PREAMBLE AND MAIN OBJECTIVES

PUMHSW have an accessible faculty dedicated to teaching, and an educational model that encourages real world experiences. They are proud of our students and their deep commitment to completing their undergraduate education and improving the world in which we live. PUMHSW has a strong commitment to the improvement of the quality of education in Nawabshah, which is realized through the collaboration with other institutions.

 WHEREAS, both the parties are desiring to work in collaboration with each other for the benefits of their students and faculty, with the prime objective of promoting education and research in fields of mutual interest.

BOTH THE PARTIES ARE AGREED UPON THE FOLLOWING TERMS AND CONDITIONS

 Second Party will give the internships to the fresh degree holders from the 1st Party. The number of internees from both the parties will be determined with the mutual consent of both

- parties depending on the modules, durations and level of internees. Party-I will consider the requirements of the party-II in recommending these trainees.
- Different seminars and workshops will be arranged time to time either in the 1st Party and 2nd
 Party with the mutual agreement. These seminars and trainings will be organized according to
 the mutual interest of both the parties.
- Both 1st Party and 2nd will conduct joint research projects and share various chemicals and raw materials for research and study purpose. Both parties will conduct research work and share the optimized data.
- 4. Research students from 1st Party can do their research work partially with 2nd Party for the fulfillment of their degree requirement on the project which is of interest to the 2nd Party as well. Research data obtained in the investigation will be jointly published.
- 5. Both parties are committed to extend their collaboration for jointly working to strengthen their knowledge-based collaboration. For this purpose, 1st Party will be leading to provide the expert solution to the problems faced by the 2nd Party. Research students and lecturers from 1st Party and 2nd Party will be involved in order to strengthen the existing products as well as to do the value addition to their products.
- 6. 1st Party and 2nd Party will share the laboratories and facilities available in these laboratories.
- A comprehensive report for each project on the completion will be prepared from both parties and will be mutually shared by both parties.
- 8. Both the parties will meet time to time to maintain the smooth working for ongoing research projects. The 1st Party will be obliged to maintain the secrecy of R & D work as per requirements of 2nd Party.
- 9. Any amendments/addition or deletion in the aforesaid MoA, if requires can be made after mutual consent of both the Parties. However, both the Parties will strictly observe official codal formalities wherever and whenever involved at either end.
- 10. This MoA or other mutual detailed agreement(s) shall automatically stand cancelled, if it is deemed necessary at any stage due to the circumstances beyond the control non-fulfillment of the obligation by any Party as laid down in the MoA.
- 11. This MoA shall come into force on the date of its signing and remain in force for a period of three (03) years extendable with mutual consent unless either Party notifies the other of its intention to terminate it by giving three months advance notice.
- In case of termination of this MoU and other agreements signed under this MoU, the decision
 on the assets of unaccomplished projects will remain the 1st Party & 2nd Party.
