

1. A meeting was held under the Convenorship of Prof. Dr. Qurban Ali Rahu, Registrar & Chairman, Central Purchase Committee(CPC) on November 25 and December 06, 2022 at 11:00 AM to evaluate the technical bids for the "Hiring of Security Service Agency (Complete Package)", PUMHSW. 
2. The meeting started with recitation of verses from the Qur-aan Paak, the Convener welcomed the members then commenced the proceeding for evaluation of Technical proposals. The Deputy Director Purchase apprised the PC members that the notice inviting tender was hoisted on the websites of PUMHWS and SPPRA. The technical bids were opened at October 26 in the presence of PC and firm's representatives. The attendance sheets were shown to the members, which shows three bids were received i.e. M/s Ababeel Security Services, M/s Rangers Security Guards and M/s Rapid Security Guards.
3. In this regard, it was briefed to the PC that technical bid will be evaluated with reference to pre-defined criteria mentioned in the bid document i.e. Mandatory Documents Required and Evaluation Criteria. The PC is empowered to accept or to reject any proposal, which fails to fulfill the specified requirements. Then PC assessed the technical bids and rated as per Evaluation Criteria. The main points of PC findings are narrated below.
4. With respect to Bidding Document, the bidder has to furnish mandatory documents as mentioned in Document Check List. The PC found that all the bidders have submitted necessary required documents and quoted guards as per requirement mentioned in bid document.




5. With respect to Bidding Document, the bidder has to furnish mandatory documents as mentioned in Document Check List. The PC found that M/s Rangers Security Gaurds and M/s Rapid Security Guards has submitted all necessary documents and quoted guards as per requirement mentioned in bid document. However, M/s Ababeel Security Services has submitted incomplete bid thus disqualified / found non-responsive.
6. Given the aforementioned comments, the Mandatory Document Checklist and the Bidder's Evaluation Report are enclosed at Annexure-A and B respectively. The PC found M/s Rangers Security Gaurds and M/s Rapid Security Guards as Responsive. Therefore, the PC recommended to open the financial bid of Technically Responsive Bidders and to return the un-opened financial bid of disqualified / nonresponsive bidder i.e. M/s Ababeel Security Services.




